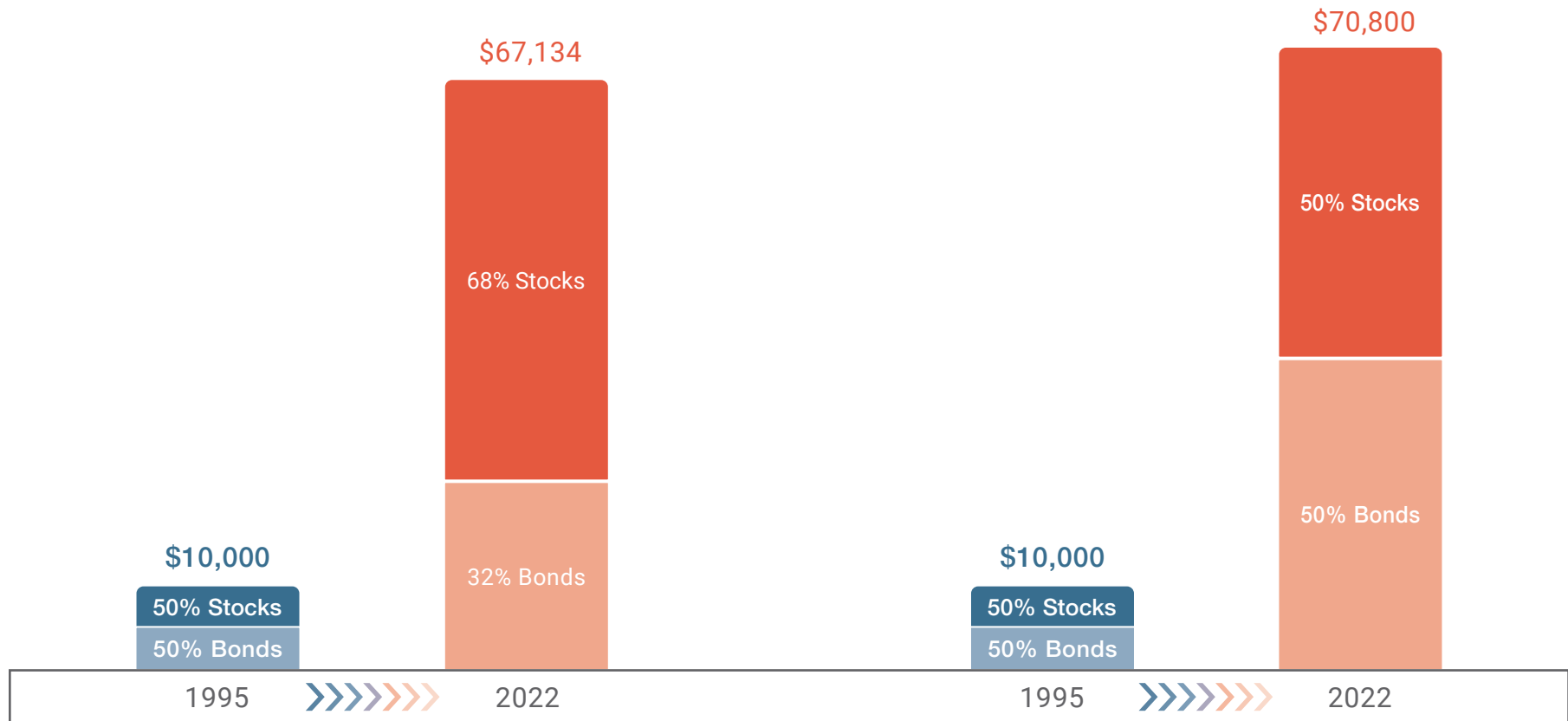


# Rebalancing Act
